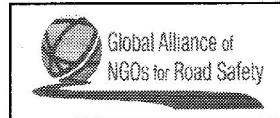

From Global Remembrance to Global Action the decade
Now it is time to learn from the past
Let's make 2011-2020 a decade to remember!
In Parma on 18 and 19 November 2012

Rome, 21 September 2012. The victim, even that of the road, protect and defend himself before the trial! The scene of the accident (many times of the crime: for example, the pirates of the road and not only) is of paramount importance. For this we have met and made a "pact" joint action with the **Italian Academy of Forensic Sciences** (<http://www.acisf.it/>) and **ANVU** (National Association of Local Police) (<http://www.anvu.it/>), **ISDE** (Doctors for the Environment, www.isde.it) to engage the best skills and experience in the investigative field: **General Luciano Garofano and former commander of the Carabinieri RIS Parma (Department of Scientific Investigations Police) and the Commander of the Local Police of Lecco, Franco Morizio (site).** To consider the theatre of the incident as a "crime scene" delimitation of the area, distribution of materials, collection of evidence and exhibits, not pollution, etc.. to come to define the Agent first responders with proper training and appropriate technical equipment (such as investigators).

Just in **Lecco** (City near Milan) high percentage of cases of pirate drivers and other road criminal events are resolved through investigative techniques worthy of the best cases of murder! For this reason we started writing to draw up guidelines for a manual in Italy also on the basis of two manuals, Road Death Investigation Manual and Crash Reconstruction Basics for Prosecutors. And that will be presented during the World Day of November.

MEMORY ORGANIZATION OF WORLD DAY VICTIMS 2012.

This year we will hold the **World Day of Remembrance for the Victims of the road** (<http://www.worlddayofremembrance.org/>) in the city of Parma.

Together with a number of organizations - Movement Salvaiciclisti, CNOSS (6 organizations of victims), Federcamminacittà (Federation of Associations of Pedestrians in Italy), IICA, Association Francesco Fiori ENOUGH POSTERS - we agreed to celebrate the occasion by combining the different initiatives, usually scheduled by each individual organization. We expect to give form, therefore, Parma, to some events which we hope will be a strong emotional impact, educational and communicative:

- an exhibition of so many crosses and white handkerchiefs as they were deaths in Italy (55,171) of the last decade in Italy (2001-2010) to expose to the world the seriousness of the social phenomenon removed
- a strengthening of the information campaign on the Decade of Action 2011-2020 and the Global Alliance of NGOs for Road Safety launched by ONU, OMS and 90 ONG in all over the world - for Italy FLG - (<http://www.roadsafetyfund.org/>)
- the presentation of a draft law framework for assistance and support for victims of road on which we are already working
- the execution of an important sporting event and information involving schools (Football match Lawyers / Judges / Strip the News)
- A radical change in the mode of action of the police in the "theatre" of the car crash.
- Rapid reform of the Fund and the direct involvement of the most representative organizations of victims.

We are pressed second our point of view, to emphasize certain emergencies: cities, their safety and their degradation, walking and cycling, routes to and from school, from home to work, young people not only for correlation with alcohol and drugs, justice and victim assistance.

The days are on 18 and 19 November 2012. Obviously we will involve all organizations socioeconomic Italian signatory of the **Decade of Action** (<http://www.decenniodazione.it/>), the ONU, OMS, the European Union (Commission and Parliament), local institutions and national Italian.

Offering a collection of funds with the Mercante's in Fiera card to all organizations involved (cyclists, pedestrians, Youth Forum, Small Towns, etc.). Donating 30% of revenues to finance their activities.

It is a duty of the State and its institutions to offer the necessary **assistance to victims of crime road** through the creation of special **service centres** - managed with the involvement of civil society organizations - in different provinces where they can receive a qualified assistance and advice in the medical, social, psychological and legal field.

Start activities **health and social care, including home care** for victims of road through a centre (with a green number, thematic portal) that will work over time as a centre of training for the **staff of local service centres** - even for law enforcement, emergency personnel, etc. - that will be progressively opened by local structures the Regions.
